The petitioner was granted anticipatory bail and one of the conditions imposed by the Court was that, he has to deposit a sum of Rs.3,00,000/- to the credit of the Crime No.899 of 2019 before the concerned Magistrate which later came to be modified Vide the order of this Court dated 04.02.2021 in Crl.M.P.No.8922 of 2020. As per the modified order the petitioner needs to deposit only Rs.2,00,000/- instead of Rs.3,00,000/-.

2.The learned counsel for the petitioner submitted that the petitioner is ready with the money to deposit but, by the time he mobilized the funds during Covid-19, the time fixed for payment has expired. Therefore, he has filed the present petition seeking extension of time..

3.The time for depositing the said sum of money is extended by four weeks from the date of receipt of a copy of this order.
