PRAYER in W.P.No.25766 of 2013 : Writ Petition filed Under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records from Ref.No.29508/ அமர்வு/விசாரணை/2012 dated 30.05.2013 and quash the same and consequently direct the respondents to follow the Rules and guidelines issued under the R.T.I.Act 2005 and pay the compensation to the petitioner.



PRAYER in W.P.No.25767 of 2013 : Writ Petition filed Under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records from Ref. No.9782/ P.T.A/2013 dated 08.05.2013 and quash the same and consequently direct the first respondent to follow the Rules and guidelines issued under the R.T.I.Act 2005 and pass suitable orders.

PRAYER in W.P.No.25768 of 2013 : Writ Petition filed Under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondent to dispose of the petitioner's representation dated 30.04.2013 and pass suitable orders.
