ORDER : The Court Made the following order :-

In view of the submission made by the learned Additional Public Prosecutor, the respondent Police is directed to complete the enquiry, within a period of four weeks from the date of receipt of a copy of this order and in the enquiry, if a prima facie case is made out against the petitioners, the respondent police shall register the First Information Report, otherwise close the petition enquiry. The respondent police is directed not to arrest the petitioners till such time.

5. This criminal original petition is disposed of accordingly with the above directions.
