ORDER

It is submitted by Mr.P.Muthukumar, learned State Government Pleader appearing on behalf of the alleged contemnors, that the relevant order required the petitioner's representation to be considered.

4. In such view of the matter, Contempt Petition No.2657 of 2016 is disposed of by leaving the petitioner free to pursue any remedy that may be available to the petitioner in respect of the decision taken on the petitioner's representation.
