Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, to direct the respondents to disburse the compensation amount for the lands comprised in Survey Nos.123/4E measuring 0.21.5 Ares (i.e. Acre 0.53 cents) and Survey No.123/7 measuring 0.7.5 Ares (i.e.Acre 0.19 cents excluding 0.05 hectares, i.e. 1.5 cents) totally measuring Acre 0.70.5 cents of Palnallur Village, Sriperumpudur Taluk, Chengalpattu District (Now Kancheepuram District) to the petitioner together with in interest and other benefits and thereafter refer the matter to civil court for enhanced compensation.
