2.Heard the learned Counsel appearing for the petitioner.

3.The learned Government Advocate (Crl.Side) submitted that the petitioner is complying with the condition regularly.

4.Considering the facts and circumstances of the case, the condition already imposed by this Court is relaxed and the petitioner is directed to appear before the respondent police, as and when required for interrogation on receipt of summons. This petition is ordered.
