When the matter was taken up for hearing, Mr.T.D.Vasu, learned counsel appearing for the petitioner sought permission of this Court to withdraw the writ petition with liberty to file an appeal against the order of the first respondent DRO dated 30.11.2020. The said statement made by the learned counsel
