Prayer in WP.655/2018: Writ Petition filed under Article 226 of the Constitution of India, praying for the issuance of writ of Certiorarified Mandamus to direct the respondents to sanction annual increment to the petitioner in respect of the service rendered by him from 01.07.2017 to 30/06/2014, and consequently



direct the respondent to revise the pension and other pensionary benefits of the petitioner and thereby pay the arrears.

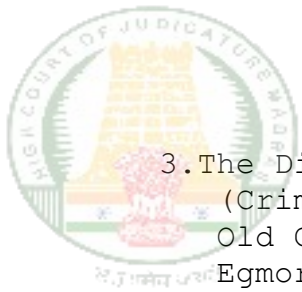
