This Writ Petition is filed for a writ of Mandamus, directing the 4th respondent to instruct the surveyor to take suitable action on the representation dated 16.12.2020 of the petitioner to survey the land of the petitioner situated at New T.S.No.27, old T.S.No.61/1A, Block-61, Ward-J, to an extent of 28,000 Sqft, Mullavadi Railway gate, Salem and secure the same by laying fence across the borders from unauthorised occupiers.

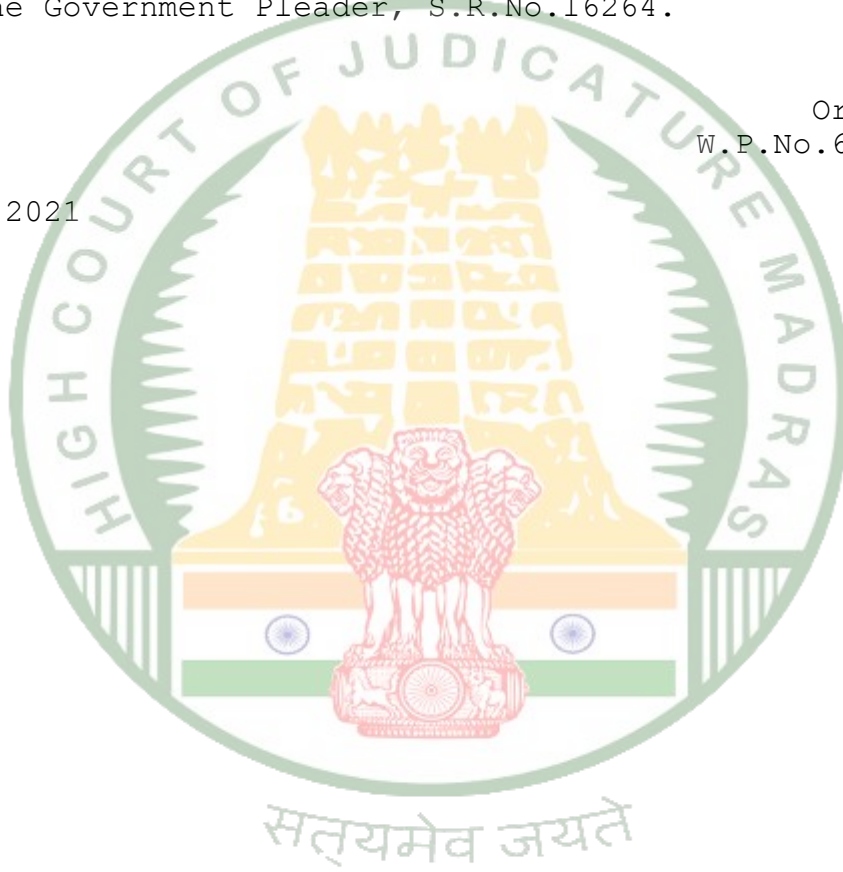
