Now, this Court directs the (*) **Deputy Inspector General/second Respondent** to hold an enquiry into the complaint of the petitioner dated 06.01.2021, after hearing all the parties who are likely to be affected by his action and provide them a fair and effective hearing and dispose of the same, within a period of 12 weeks from the date of receipt of a copy of this order.

5. Accordingly, this writ petition stands disposed of. No costs.
