ORDER

The petitioner has preferred a representation dated 02.03.2021 to the Tahsildar, Madukkarai Taluk, to survey and measure the property in Old.S.No.14/1. R.S.No.1283/14, Madukkarai Taluk, Coimbatore District.

2. Heard the learned counsel for the petitioner. Mr.S.N.Parthasarathi, learned Government Advocate made a statement on instructions that the enquiry for the purpose is scheduled to take place at 11.00 a.m., on 09.04.2021 at the Office of the Tahsildar, Madukkarai Taluk / second respondent. He also added that the survey of the land is proposed to take place on 16.04.2021. The said statement is recorded.

3. Inasmuch as the date for enquiry is fixed by the respondents, no direction is required to be given except that the second respondent/ Tahsildar, Madukkarai Taluk is directed to hold an enquiry after issuing notices to all the parties who are likely to be affected by his decision, and after providing the parties a fair and effective hearing and to dispose of the said representation through a speaking order within a period of twelve (12) weeks from the date of service of order copy, subject to such time that may be lost in responsibilities connected with the General Election-2021 of the Tamil Nadu State Legislative Assembly.

4. The writ petition is disposed of accordingly. No costs.
