2. This Court, vide order dated 21.12.2020 directed the petitioner to report before the respondent police on the first day of every month, until further orders.

3. Learned Government Advocate (Crl.Side) submits that the petitioner has been complying with the conditions imposed by this Court.

In the above circumstances, this petition is allowed and the earlier condition imposed by this Court in Crl.M.P.No.8452 of 2020 in Crl.O.P.No.12589 of 2020 dated 21.12.2020 shall continue till the filing of charge sheet and thereafter, appear before the trial Court on all hearing dates without fail. Except the above modification condition, all other conditions imposed by this Court in its order dated 21.08.2020 in Crl.O.P.No.12589 of 2020 stand unaltered.
