within a period of six months from the date of receipt of the
Order.

iii] That the learned Sole Arbitrator appointed herein
shall be paid fees as per the schedule and the same shall be
borne by the parties equally.

5. This Original Petition is ordered accordingly, leaving the parties to bear their own costs.

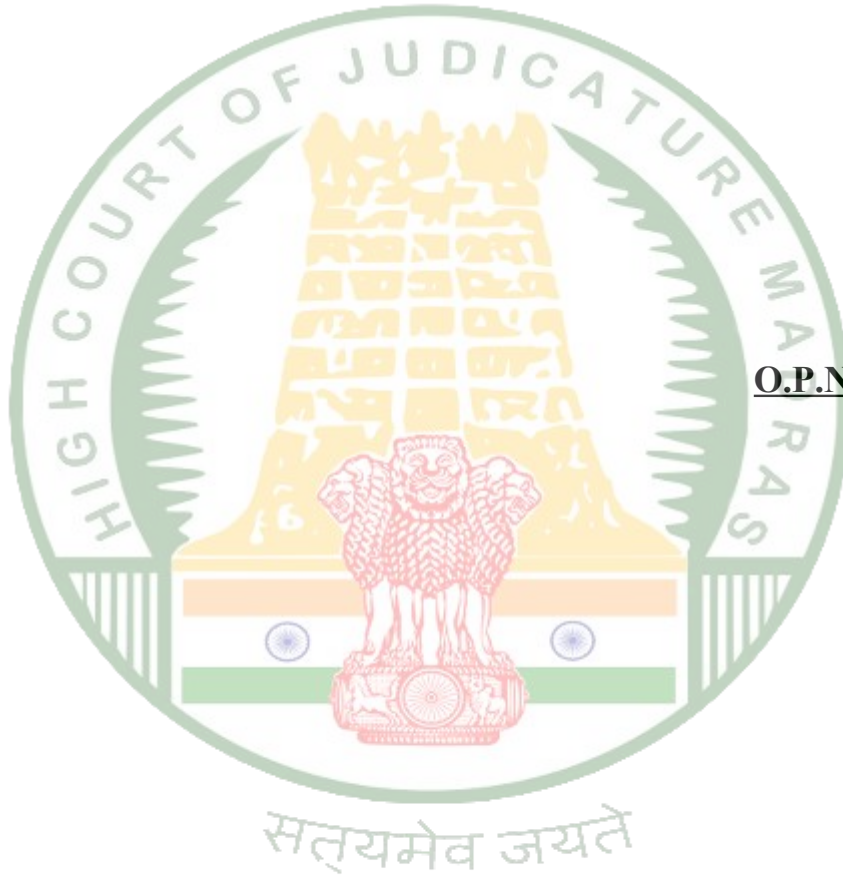
