Till such time, the petitioners shall not be arrested by the respondent police.

5. This criminal original petition is disposed of accordingly with the above directions.

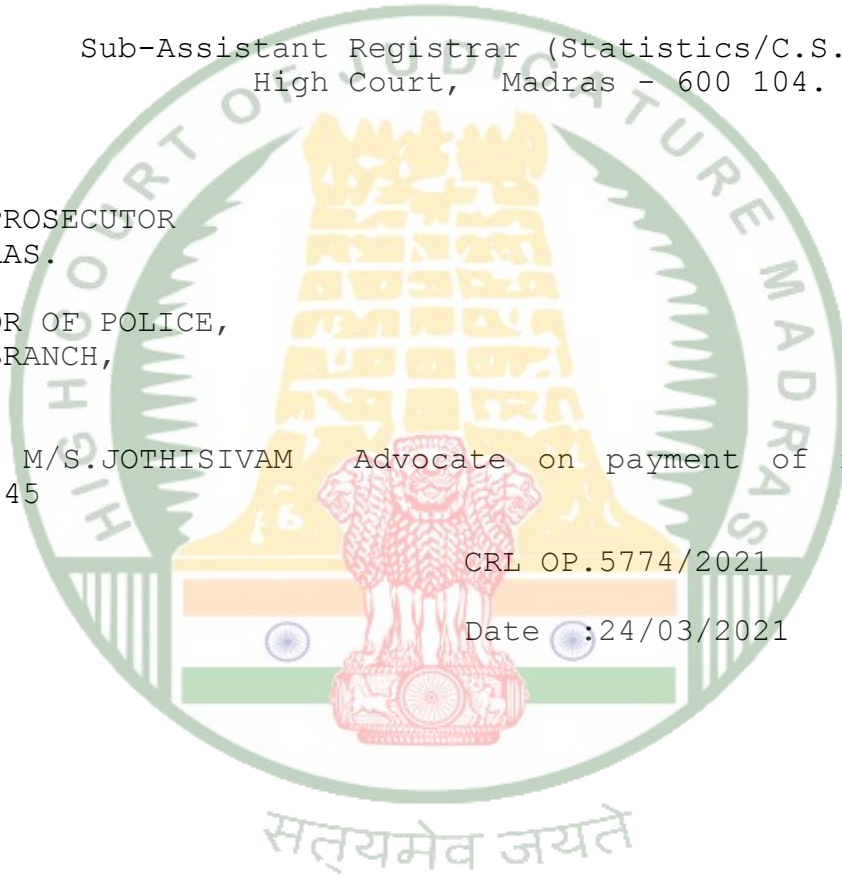
