3.Having regard to the limited scope of the petition, this Court, without expressing any opinion on the merits of the petitioner's representation, directs the third respondent to consider the representation submitted by the petitioner dated 22.02.2021 and to dispose of the same in accordance with law, after issuing notice to the petitioner and to other interested persons, if any. This exercise shall be done by the third respondent within a period of eight weeks from the date of receipt of a copy of this order.
