ORDER

In view of the above, no further direction is required to be given except that the Revenue Divisional Officer, Tittakudi Taluk is directed to hold an enquiry after issuing notices to all the parties who are likely to be affected by his decision, and after providing the parties a fair and effective hearing and to dispose of the appeal dated 20.10.2020 preferred by the petitioner, through a speaking order within a period of twelve (12) weeks from 24.05.2021.

4. The writ petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
