3.The learned Additional Public Prosecutor submitted that the petitioners are complying with the condition regularly.

4.Considering the facts and circumstances of the case, the condition already imposed on the petitioners is relaxed and the petitioners shall appear before the respondent police, once in a week for interrogation on receipt of summons. This petition is ordered.
