2. By order dated 25.06.2021, while declining to modify the above said condition, extended time for the deposit of amount as directed by this court till 16.07.2021 and directed the matter to be listed to day for reporting compliance. It is accordingly listed today.



3. The learned counsel for the petitioner submitted that after extension of time granted by this court, the petitioner has deposited the amount and furnished sureties as directed by this court and therefore, nothing survives in this miscellaneous petition for further adjudication.
