Earlier this Court by an order dated 18.09.2020, granted anticipatory bail to the petitioners with a condition to execute sureties within a period of two weeks, since the petitioners were not able to execute the sureties, this Court by an order dated 18.01.2021 in Crl.M.P.No.8811 of 2020 in Crl.O.P.No.14623 of 2020 further granted two weeks time to execute the sureties. Even though the copy of the order was made ready on 29.01.2021, the same was received by the petitioners on 08.02.2021, hence the petitioners were not able to execute the sureties. Hence the petitioners have filed the present miscellaneous petition seeking further extension of time.

2. Considering the facts and circumstances of the case, this petition is ordered and two weeks time is granted to the petitioners to comply with the conditional order passed by this Court, from the

date on which the order copy was made ready. Failing which, the petition for anticipatory bail shall stand automatically dismissed.
