PRAYER : Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Certiorarified Mandamus, to call for the entire records of the 2nd respondent in so far as the High Tension Bill (Provisional) for the month of April 2020 dated 08.05.2020 and May 2020 dated 06.06.2020 pertaining to High Tension Consumer Connection vide Service No.019094061669 and quash the same and consequently direct the respondents to rework the HT Bill with Service No.019094061669 and the excess amount shall be adjusted towards the future bills by levying the minimum charges alone by the 2nd respondent for the period from April 2020 to July 2020 and not to levy any penalty for the period under which the petitioner's furniture-cum-computer products was lockdown.
