The petitioner is mother of the detenu viz., S.Gowtham S/o.Senniappan, aged 22 years. The detenu has been detained by the second respondent by his order in C.No.14/G/IS/2021 dated 15.03.2021, holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

Learned Government Advocate [Crl.side] would submit that the detention order passed against the detenu in C.No.14/G/IS/2021 dated 15.03.2021, on the file of the second respondent is revoked vide G.O.Rt.No.2072, Home, Prohibition and Excise (XII) Department, dated 04.05.2021 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
