ORDER

The petitioners have made atleast two representations one on 15.10.2020 and the other on 05.03.2020, for transfer of patta and mutation of revenue records in their names.

The said statement is recorded.

In view of the above, no further direction is required to be given except that the Tahsildar, Arakkonam Taluk, Vandavasi District is directed to hold an enquiry after issuing notices to all the parties who are likely to be affected by his decision, and after providing the parties a fair and effective hearing and to dispose of the said representation through a speaking order within a period of eight (8) weeks from 01.06.2021.

4. The writ petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
