ORDER

The petitioners, who apprehend arrest at the hands of the respondent police for the alleged offence under Section 420 of IPC in Crime No. not known on the file of the respondent police, seeks anticipatory bail.

2. Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor appearing for the respondent.

3. When the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent Police submitted that petition enquiry in C.S.R.No.72 of 2018 is pending against the petitioners. He further submitted that the first petitioner is no more.

4. In view of the submission made by the learned Additional Public Prosecutor, the respondent Police is directed to complete the enquiry, within a period of four weeks from the date of this order, and to submit a copy of this order and if any prima facie case is

made out against the second petitioner, the respondent police shall register the First Information Report or close the petition enquiry. Till then, the respondent police is directed not to arrest the second petitioner.

5. Accordingly, this criminal original petition is dismissed against the first petitioner and is closed as against the second petitioner.
