The petitioner is the wife of the detenu viz., Rajkumar S/o.Vedantham, aged 34 years. The detenu has been detained by the second respondent by his order in BCDFGISSSV No.29/2021 dated 06.03.2021, holding him to be a "Bootlegger", as contemplated under Section 2(b) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2. Learned Government Advocate [Crl.side] would submit that the detention order passed against the detenu in BCDFGISSSV No.29/2021 dated 06.03.2021, on the file of the second respondent is revoked vide G.O.Rt.No.1900, Home, Prohibition and Excise (XI) Department, dated 26.04.2021 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
