Vide order dated 03.09.2020 this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions imposed in the Miscellaneous Petition Crl MP. No. 6166 of 2020 .

2. Learned Government Advocate (Crl.Side) appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.



3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed in order dated 14.10.2020 in Crl.MP.No 6166 of 2020 is further relaxed and the petitioner shall appear before the respondent police on 1st Monday of every month at 10.30 am till the investigation is completed. Thereafter, the petitioner shall appear before the trial court on the dates of hearing.
