When the matter is called today, Mr. R.Udayakumar, learned Special Government Pleader for the appellants would submit that he received the order copy only on 26.03.2021 and by that time, the model code of conduct had come into force resulting in delay in processing the file and therefore, the appellants could not deposit the amount by 06.04.2021. Hence, the present C.M.P. has been filed seeking extension of time to comply with the order dated 09.02.2021 regarding deposit.

2. Considering the submission made by the learned Special Government Pleader for the appellants, time is extended till 1st June, 2021 for deposit of the sum of Rs.7,50,00,000/- (Rupees Seven Crore and Fifty Lakhs only) to the credit of O.S.A. No. 286 of 2020.
