2. The issue involved is with respect to the allotment of the distributorship. It prima facie appears that the first respondent/writ petitioner did not comply with the mandate of registered document.

3. In our considered view, the learned Single Judge has misconstrued the scope of Section 47 of the Registration Act, particularly when the unregistered document produced earlier and thereafter registered document dealt with different dates.

4. In such view of the matter, status quo earlier granted is made absolute. This miscellaneous petition is disposed of.
