PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

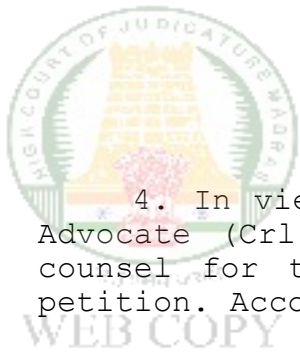
ORDER : The Court Made the following order :-

(The case has been heard through video conference)

The petitioners apprehend arrest at the hands of the respondent police for the offences punishable under Sections 498 and 406 of IPC read with Section 4 and 6 of the Dowry Prohibition Act, in Crime No.Not known of 2021 seeks anticipatory bail.

2. The learned Government Advocate (Crl.Side) has submitted that on on 30.6.2021, the further action on the complaint given by the defacto complainant in CSR.No.40 of 2021 has been dropped and the enquiry was closed on the ground that she will work out her remedy in a petition filed by her in O.P.No.1961 of 2021 pending on the file of V Addl. Family Court, Chennai.

3. Mrs.K.Sumathi, learned counsel for the petitioners has submitted that there was no amicable settlement between the parties, since the first petitioner/first accused/husband of the defacto complainant was in abroad and the same may be recorded.



4. In view of the submissions made by the learned Government Advocate (Crl.Side) and recording the submission of the learned counsel for the petitioners, nothing further survives in this petition. Accordingly this Criminal Original Petition is closed.
