PRAYER: The Writ Petition has been filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the respondents to pass orders granting cadre conversion to the petitioner from the post of JE Electrical Gr.I to AE/Electrical from May 2007 in the light of re-fixation of seniority of the petitioner in the post of JE Electrical Gr.I from May 2007 as per the orders passed by the 2nd respondent in Memo No.88345/330/G.1/G.1(2)/2015-28 dated 13.08.2020 with consequential promotion to the post of Assistant Executive Engineer/Electrical on par with petitioner's junior and other service benefits, based on the representation submitted by the petitioner dated 02.01.2021 within a time frame.
