3. Learned Government Advocate (Crl.Side) appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

4. In view of the above stand position, recording the submission of the learned counsel for the petitioner, the condition in so far as appearance of the petitioner is relaxed and the petitioner shall



appear before the respondent as and when required for interrogation on receipt of requisite summons. All other conditions remain unaltered.
