2. Heard the learned counsel for the petitioner.

3. The learned Government Advocate appearing for the State submitted that the petitioner is complying with the conditions regularly.

4. Though, the petitioner was granted bail on 13.08.2020 on certain conditions, those conditions have been relaxed twice and now the petitioner is directed to report before the respondent Police



only once in a month at 10.30 a.m., until further orders. Therefore, this Court is not inclined to relax the condition as imposed by this Court in Crl.M.P.No.7959 of 2020 in Crl.O.P.No.11176 of 2020.

5. Accordingly, this petition is dismissed.
