Though this petition has been filed seeking leave, after going through the order passed by the learned single Judge, this Court is of the view that the remedy open to the petitioners is to approach the learned single Judge, contending that the order has been passed wrongly recording the submission made as if it is a consent order. We are also of the view that this being the Court of record, it is the proper remedy instead of filing an appeal.
