PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent Police for the offence punishable under Sections 420, 471, 468 and 506(II) of IPC 1860, in Crime No.(Not known), seeks anticipatory bail.

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.Side) appearing for the respondent.

3. When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent Police submitted that petition enquiry is pending against the petitioner.

4. In view of the above submission made by the learned Government Advocate (Crl.Side), the respondent Police is directed to complete the enquiry, within a period of two weeks from the date of receipt of a copy of this order and in the enquiry, if a prima facie case is made out against the petitioner, the respondent police shall register the First Information Report, else the petition be closed. It is needless to state that pending the enquiry, the respondent police shall not resort to any coercive action or harass the petitioner and shall take any lawful action in accordance with law on the basis of the result of the enquiry.

5. This Criminal Original Petition is disposed of accordingly.

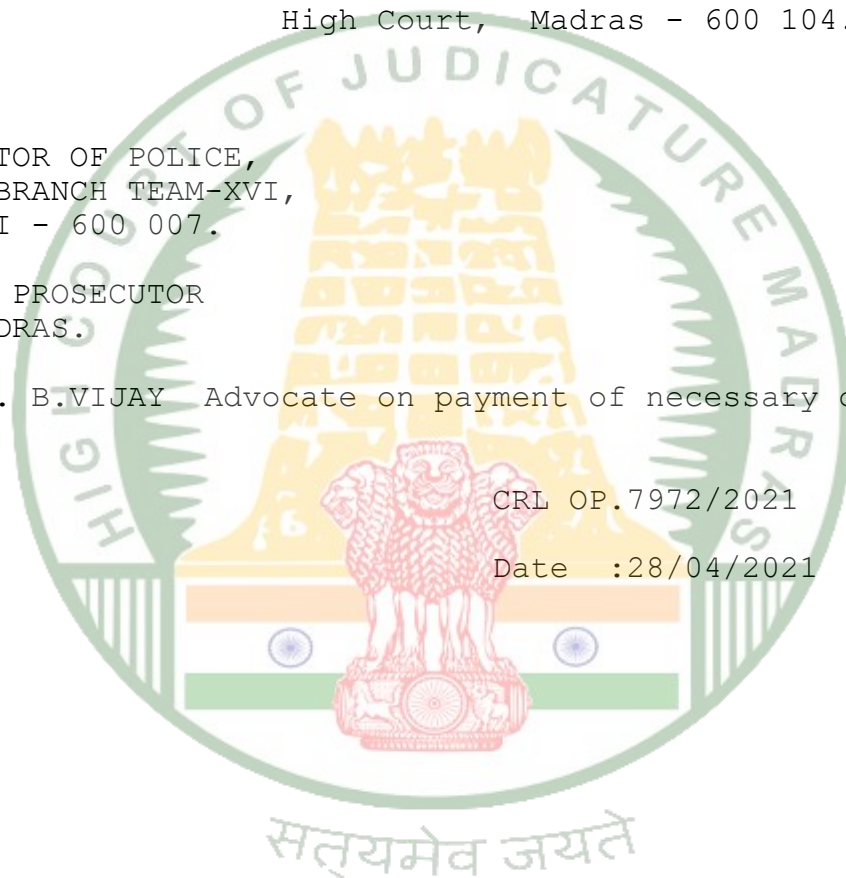
