Writ Petition has been filed seeking for issuance of a Writ of Mandamus, forbearing the respondents their men and agent and persons claiming through them from interfering with the petitioner's peaceful possession and enjoyment of 5 cents of land in S.No.422 of Umayalpranancheri Village, Sriperumbudur Taluk, Kancheepuram District and issue patta based on the petitioner's representation dated 10.05.2018.
