PRAYER in W.P.No.10582 of 2021:Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus Calling for the records connected with the impugned orders dated 15.05.2014 passed by the 4th respondent vide his proceedings Lr.No. P1/ 15660/ Pen/ Ho/ 2014 and subsequent orders dated 16.04.2020 passed by the 3rd respondent vide his proceedings Lr.no.1604/ Supt/ F.Court case/ 2020/ RWS/ VPM and quash the same and further direct the 1st respondent to pass orders conferring permanent status to the petitioner on 24.02.1975 on completion of 480 days continuous service in a period of 24 calendar months as per the 12 (3) settlement dated 08.08.1996 duly permitting to move selection Grade Special Grade and super Grade on completion of 10 years

20 years and 30 years of service on 24.06.1985, 24.06.1995 and 24.06.2005 in the respective scale of pay for the post of office Assistant duly permitting to draw arrears of pay allowances and other attended benefits extended to all other workmen on merits.

PRAYER in W.P.No.10588 of 2021: Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus Calling for the records connected with the impugned orders dated 15.05.2014 passed by the 4th respondent vide his proceedings Lr.No. P1/ 15660/ Pen/ Ho/ 2014 and subsequent orders dated 22.04.2020 passed by the 3rd respondent vide his proceedings Lr.no. 224 / Supt/ F.Court case/ RWS/ KK/ 2020 and quash the same and further direct the 1st respondent to pass orders conferring permanent status to the petitioner on 29.07.1974 on completion of 480 days continuous service in a period of 24 calendar months as per the 12 (3) settlement dated 08.08.1996 duly permitting to move selection Grade Special Grade and super Grade on completion of 10 years 20 years and 30 years of service on 29.07.1984 29.07.1994 and 29.07.2004 in the respective scale of pay for the post of office Assistant duly permitting to draw arrears of pay allowances and other attended benefits extended to all other workmen on merits.

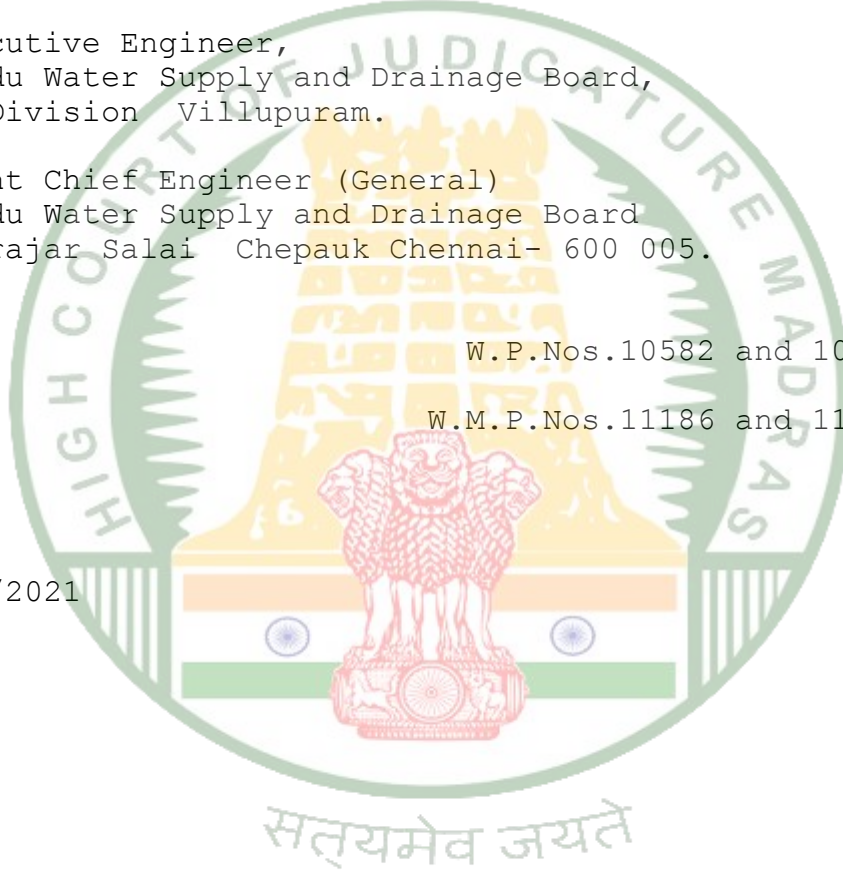
