Today when the Contempt Petition is taken up for hearing, Mr.R.Baskaradoss, learned counsel appearing for the petitioner, on instructions, would submit that, pursuant to the order of this Court, initially since orders have not been complied with, this Contempt Petition was filed. However, when the Contempt Petition was kept pending, subsequently on 11.11.2019, the respondents have passed an order of course rejecting the plea of the petitioner, as against which, the petitioner has already started working out his remedy in the manner known to law and hence, this Contempt Petition, by recording the aforesaid development, may be closed, he contended.
