The Petitioner has filed this petition seeking to relax the condition imposed by this Court in Crl.O.P.No.11599 of 2020 in paragraph 5(d) for the offences punishable under Sections 21(d) (h) of Tamil Nadu Forest Act Vth Act 1882, 9(1) and 51 of Wildlife Protection Act 1972, Sec.429 IPC and 9(B), 1(b) of Explosive Act 1884 and u/s 286 IPC 9(B) 1(b) Act 1884 r/w 5 of Explosive Substances Act 1908 in W.L.O.R.No.11/2020, while granting bail.

2.Heard the learned Counsel appearing for the petitioner.
