## ORDER

appeal on merits and in accordance with law. Consequently, connected miscellaneous petition is closed. No order as to costs.

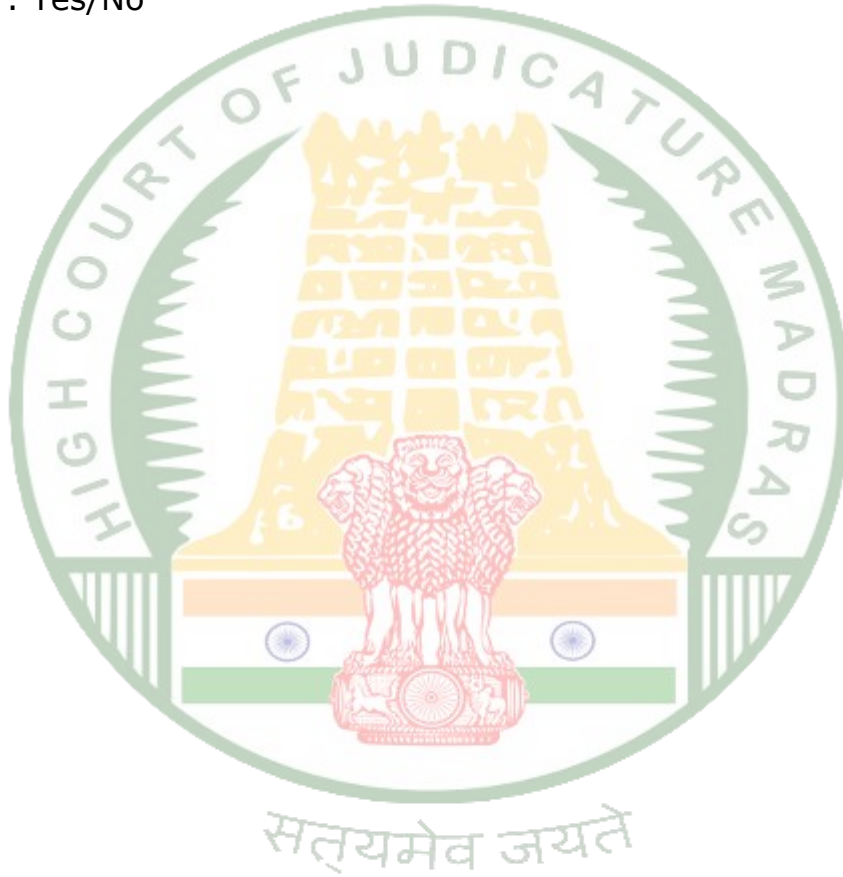

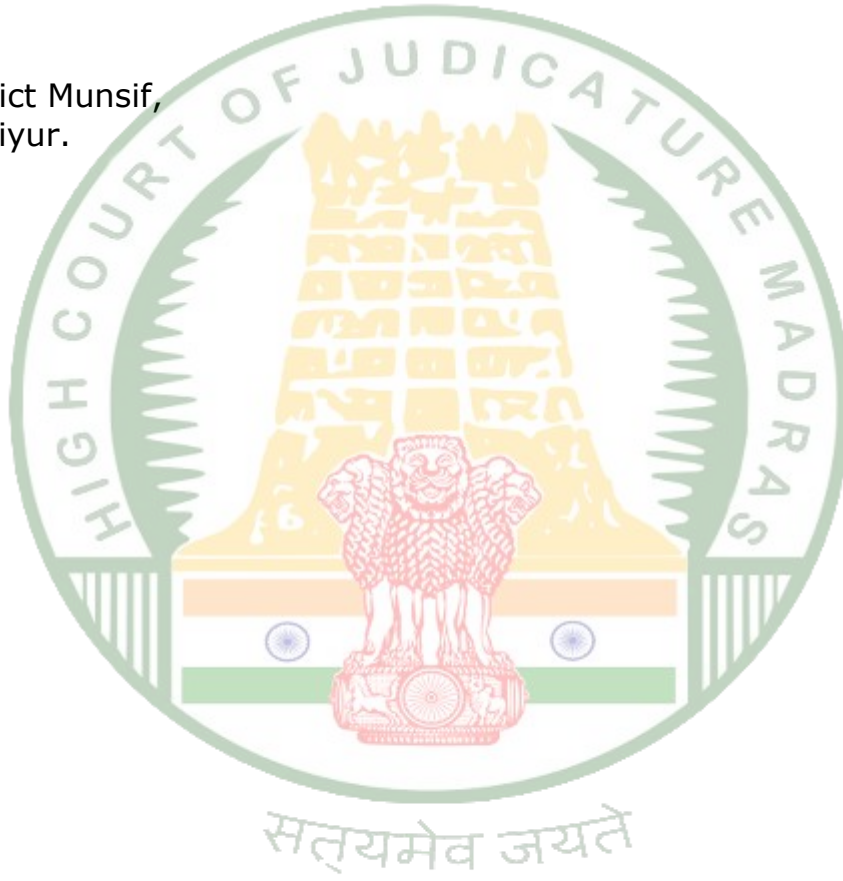

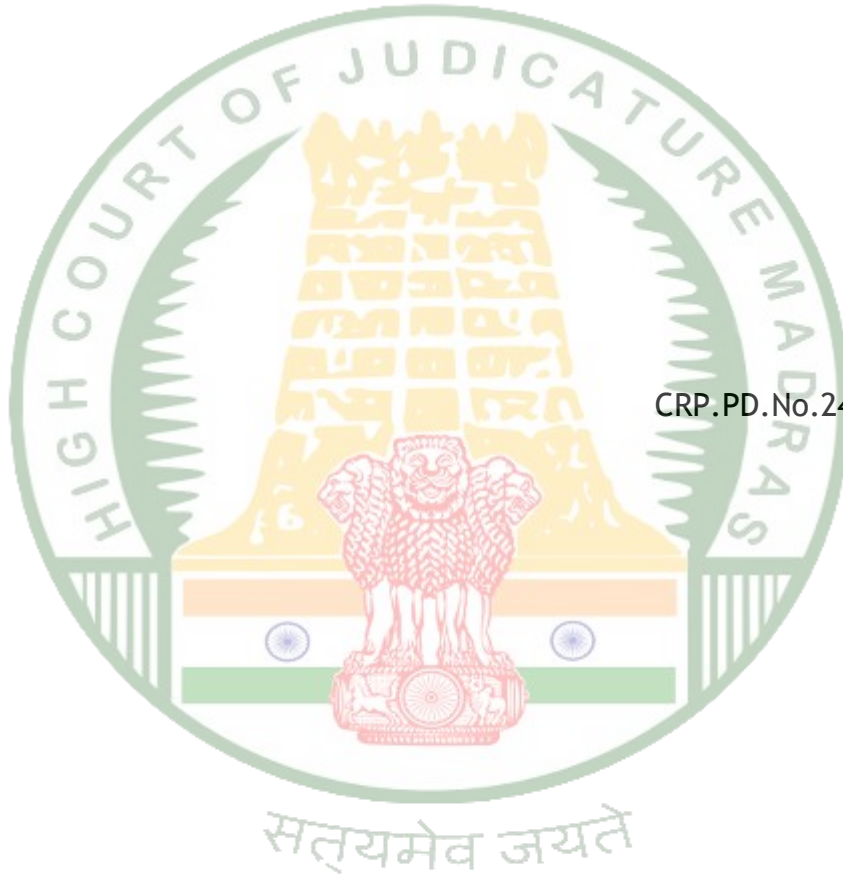
