Notice was also served to the Respondents 1 and 2 through Court as well as privately but none appeared for them till date.

4. Learned Counsel for the Petitioners further submitted that, the Suit is of the year 2012 and he has filed the Civil Revision Petition in the year 2016 to fix a time frame to dispose of the Suit by the learned District Munsif Court, Perambalur.
