4.Taking into consideration, the facts and circumstances of the case, the petitioner shall submit a fresh representation to the third respondent and the third respondent shall consider the representation dated 23.12.2020 submitted by the petitioner in accordance with the guidelines given by this Court in Sabari @ sabarigiri Vs. Assistant Commissioner of Police, Annanagar (L and O) Range, Madurai City, Madurai and others, reported in 2018 (4MLJ) Criminal page 585 and pass appropriate orders within a period of six weeks from the date of receipt of the representation of the petitioner.

5.Accordingly, this Writ Petition is disposed of with the above directions. No costs.
