The petitioner was involved in a Traffic offence on 25.09.2020 and the Traffic Police issued a traffic fine Challan No.TN4381520 0925191618 for Rs.1000 + Rs.100 totally (Rupees One Thousand and One Hundred Only). Though the petitioner is ready to pay the fine amount before the learned XXIII, Metropolitan Magistrate, Saidapet, but he is unable to pay the said amount, since the bench clerk informed that the case sheet is not with the Court. 4.With the above direction, this Criminal Original Petition is disposed of.
