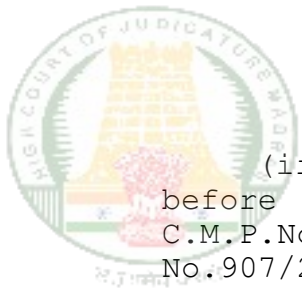

Order : This Petition coming for Extension of time on the Sixth day of January Two Thousand Twenty Two and perusing the earlier order dated 24/08/2021 and letter dated 17/12/2021 vide D.No.12617 from the Principal Judge (FAC), City Civil Court, Chennai - 104, this court made the the following order :-

By an order dated 24.08.2021, this Court allowed C.R.P.(NPD). Nos.907 & 908 of 2016, with a direction to the Trial Court to dispose of E.A.Sr.No.7007 of 2016 in E.P.No.3163 of 2014 within a period of four weeks from the date of receipt of a copy of that order.
