2. The learned counsel for the petitioner submitted that due to Covid-19, the petitioners are unable to mobilise funds and prays to reduce the amount imposed by this Court in Crl.O.P.No.6384 of 2021 dated 15.04.2021.



4. On perusal of records it is seen that the petitioners has looted 240 sovereigns of gold hence this Court directs the petitioners to deposit a sum of Rs.4,00,000/- to the credit of crime no.

5. In view of the above, this Court is of the opinion that the amount imposed by this Court is just and reasonable and no interference is required. **Accordingly, this Criminal Miscellaneous petition is dismissed.** However, he petitioner is granted further period of four weeks from the date of receipt of a copy of this order to deposit a sum of Rs.4,00,000/- to the credit of crime no.
