2.This Court while granting anticipatory bail, directed that the petitioner should report before the respondent police daily at 10.30 a.m. for a period of two weeks and thereafter as and when required for interrogation.

3. However, the learned counsel appearing for the petitioner would submit that there is a life threat to the petitioner at the hands of the defacto complainant, in the event of complying the above said condition and prays for modification of the said condition.

4. This Court, considering the request made by the petitioners, is inclined to modify the condition. Accordingly, the petitioner is directed to appear before the Thirunelveli Town Police Station on daily basis at 10.30 a.m. for a period of two weeks.

5. Accordingly, this Criminal Miscellaneous Petition is ordered.
