The petitioner was granted bail by this Court vide order dated 27.04.2021. However, a condition was imposed that one of the sureties must be a blood surety.

The petitioner's counsel states that when the petitioner's wife went for execution of the surety, the same was refused and for this reason, he wants modification. Hence, the said condition is modified as "any other surety".

The other conditions imposed by this Court will remain intact.

The miscellaneous petition is allowed accordingly.
