The Petitioner has filed this petition seeking to relax the condition imposed by this Court in Crl.O.P.No.5495 of 2021 for the offences punishable under Section 174 of Cr.P.C., which was later altered into 306 IPC in Crime No.1426 of 2019, while granting bail.

2.Heard the learned Counsel appearing for the petitioner.

3.The learned Additional Public Prosecutor strongly opposes this petition and submitted that the petitioner has been complying with the conditions only from 26.03.2021.

4.It is seen from the submission that the petitioner has been complying with the conditions only from 26.03.2021. However, considering the prevailing COVID-19 situation, this Court is inclined to relax the conditions already imposed on the petitioner, who shall appear before the respondent-police as and when required for interrogation. This petition is ordered.
