The said order is under challenge in this Habeas Corpus Petition.

Learned Additional Public Prosecutor would submit that the detention order passed against the detenu in Cr.M.P.No.9/Goonda/2021 dated 15.04.2021, on the file of the second respondent is revoked vide G.O.Rt.No.2637, Home, Prohibition and Excise (XII) Department, dated 14.06.2021 and produced a copy of the said order.
