The Petitioner has filed this petition seeking to relax the condition imposed by this Court in Crl.O.P.No.5824 of 2021 for the offences punishable under Sections 341, 294(b), 120-B and 302 of IPC in Crime No.84 of 2021, while granting bail.

2.Heard the learned Counsel appearing for the petitioner.

3.The learned Additional Public Prosecutor submitted that the petitioner has been complying with the conditions only from 03.05.2021 to 09.05.2021.

4.It is seen from the submission that the petitioner has been complying with the conditions only from 03.05.2021 to 09.05.2021, i.e., for six days. However, considering the prevailing COVID-19

situation, this Court is inclined to modify the condition to the extent that the petitioner is directed to appear before the respondent-police once a week every Monday instead of appearing before the Inspector of Police, Anna Nagar, Madurai until further orders. This petition is ordered.
