2.Heard the learned Counsel appearing for the petitioner.

3.The learned Additional Public Prosecutor strongly opposes this petition and submitted that the petitioner has been complying with the conditions only from 25.04.2021.

4.It is seen from the submission that the petitioner has been complying with the conditions only from 25.04.2021. However, considering the prevailing COVID-19 situation, this Court is inclined to relax the conditions already imposed on the petitioner, who shall appear before the respondent-police as and when required for interrogation. This petition is ordered.
