4.It is seen from the submission that the petitioners have been complying with the conditions only from 19.04.2021. However, considering the prevailing COVID-19 situation, this Court is inclined to relax the conditions already imposed on the petitioners, who shall appear before the respondent-police as and when required for interrogation. These petitions are ordered.
